**TOWN AND COUNTRY PLANNING ACT 1990**  
**APPEAL BY LONDON CITY AIRPORT LIMITED**  
**SITE ADDRESS: LONDON CITY AIRPORT, HARTMANN ROAD, ROYAL DOCKS, LONDON, E16 2PX**

I refer to the above appeal proposals and enclose copies of the Updated Environmental Statement (September 2015) and other supporting documentation.

As advised in our letter dated 31 July 2015, the Airport has taken the opportunity to update the CADP Consolidated Environmental Statement (November 2014) to take account of the passage of time since the original Environmental Statement was prepared in 2013. The Updated Environmental Statement (UES) (September 2015) also takes account of two proposed minor changes to the application drawings. Enclosed is a guide to the Submitted Material which explains the status of documents relative to those previously submitted.

I enclose 2 copies of the following:

- **A Guide to the Submitted Material** which provides an explanation of the submission and explains the status of all previously submitted documents.
- **Updated Environmental Statement, (September 2015) Volumes 1-5** (including Non-Technical Summary & CD-ROM)
- **Consolidated Application Plans (September 2015) Folder** (A3 sized) which provides all of the current application drawings (most recently revised in February 2014) together with the proposed modified drawings showing the proposed minor changes (in a separate tab).
- **Proposed Minor Changes (September 2015) Folder** which provides an explanation of the proposed minor changes and updates/supplements relevant supporting documentation.
- **Updated Reports (September 2015) Folder** which provides updates to supporting application documents, including an Updated Transport Assessment, Updated Health Impact Assessment and Update to the Need Statement.
- **A CD-ROM of the Submitted Material** with electronic copies of all of the enclosed information including a track change version of the UES to highlight the changes to the November 2014 CES.
- **A CD-Rom of the Application Documents** that contains all documentation (included the Submitted Material) which has not been superseded and remains relevant to the determination of the proposals (see enclosed guide).
- **Notice of Submission** – which has been used to publicise the submission (see below).



I confirm that paper copies of the documentation have also been sent to the London Borough of Newham the Greater London Authority (x2).

**a) Publicity and Consultation**

The enclosed Notice of Submission has been used to publicise the Submitted Material via site notices, newspaper advertisements and notifications to local residents. The attached plan shows the location of the displayed site notices (250no.) which follows the previous approach taken to publicity by the London Borough of Newham for the application. The contour on the plan shows how these relate to the With CADP 2025 56dB noise contour. That noise contour has also informed the extent of the distribution of neighbour notification letters. In total 25,390 letters have been sent out to residents within this contour area. In addition letters or emails have been sent to the Statutory Consultees who were previously consulted by the Borough and also to those who made comments on the application. Newspaper notices have, or will be published, on the following dates in local newspapers:

- Monday 7 September - East End Life;
- Tuesday 8 September - Royal Greenwich Times ;
- Wednesday 9 September - Docklands East, London Life, Newham & Stratford Recorder, Greenwich & Lewisham Mercury;
- Thursday 10- September - The Wharf ; and
- Friday 11 - Newham Mag.


The notice explains the documentation is available online and a 6 week consultation period is available for representations to be made (closing on 26 October 2015). The notice also explains where paper copies of documentation can be viewed (at LB Newham's Offices and Local Libraries). As agreed with PINS, the notice asks for any comments to be sent directly to the Planning Inspectorate, quoting the appeal reference and marked for your attention.

**b) Availability of the information**

As advised in the notice, a paper copy of the Submitted Material can be provided to interested parties (while stocks last) for a cost of £200 for each volume (excluding postage and packing). Copies of the Non-Technical Summary can be obtained free of charge.
