#### **NOTE OF COMPLIANCE WITH STATUTORY NOTICE REQUIREMENTS**

##### **The SRO**

5. A copy of the order and of the plans were deposited at County Hall, Truro, Cornwall TR1 3AY on 17 November 2022 and will remain available for inspection until such time as a decision on the SRO is made.
6. The made SRO was submitted to the National Transport Planning Casework Team under cover letter dated 2 December 2022. A copy of the covering letter appears at Tab 4.
7. A copy of the authority's Statement of Case has been sent to all those that submitted representations in response to the making of the SRO. A copy of the Statement of Case together with related documents (with appropriate redactions of personal data) has also been published on the authority's website at (<https://www.cornwall.gov.uk/planning-and-building-control/places/langarth-garden-village/>).

##### **The CPO**

8. The CPO was made on 4 November 2022, shortly after the SRO.
9. A notice in the Form numbered 7 in the Compulsory Purchase of Land (Prescribed Forms) (Ministers) Regulations 2004 (SI 2004 No. 2595) was published in two issues of the West Briton dated 17 November 2022 and 24 November 2022 (being a local newspaper circulating in the locality). The time allowed for objections was not less than 21 days from the date of the first publication of the notice. Copies of both notices are available at Tab 5.
10. A notice in the same Form addressed to persons occupying or having an interest in the land was affixed to a conspicuous object or objects on or near the land comprised in the order on 17 November

2022 and from that date remained in place for a period of at least 21 days. Photographs of the site notices appear at Tab 6.

11. Notices in the Form numbered 8 in the said Regulations were duly served on:
  - a. every owner, lessee, tenant and occupier of all land to which the order relates;
  - b. every person to whom the acquiring authority would, if proceeding under section 5(1) of the Compulsory Purchase Act 1965, be required to give a notice to treat; and
  - c. every person the acquiring authority thinks is likely to be entitled to make a claim for compensation under section 10 of the 1965 Act if the order is confirmed and the compulsory purchase takes place, so far as such a person is known to the acquiring authority after making diligent inquiry.
12. The time allowed for objections in each of the notices was not less than 21 days. The notices were served by one or more of the methods described in section 6(1) of the 1981 Act. Confirmation of the service of notices is provided at Tab 7. Notices included a copy of the authority's Statement of Reasons for making the CPO, together with copies of the documents referred to therein.
13. A copy of the CPO and of the map were deposited at County Hall, Truro, Cornwall TR1 3AY on 17 November 2022 and will remain available for inspection until a decision on the confirmation of the CPO has been issued.
14. The made CPO was submitted to the Planning Casework Team under cover letter dated 2 December 2022. A copy of the covering letter appears at Tab 8.

### **THE BRENT (WAITING AND LOADING RESTRICTION)**

#### **(AMENDMENT NO. 603) ORDER 2022**

#### **THE BRENT (GOODS VEHICLES) (FREE LOADING PLACES) (NO. 4) ORDER 2022**

1. NOTICE IS HEREBY GIVEN that the Council of the London Borough of Brent on 14th November 2022 made the above-mentioned Orders under sections 6, 45, 46, 49 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended by section 8 of and Part I of Schedule 5 to the Local Government Act 1985.

2. The general effect of the 'Waiting and Loading Restriction' Order will be to further amend the Brent (Waiting and Loading Restriction) Order 1979, so that:-

(a) waiting by vehicles (otherwise than for the purpose of delivering or collecting goods or loading or unloading a vehicle) will be prohibited at any time in the lengths of streets specified in Schedule 1 to this Notice;

(b) waiting by vehicles (for the purpose of delivering or collecting goods or loading or unloading a vehicle) will be prohibited at any time in the lengths of street specified in Schedule 2 to this Notice;

(c) waiting by vehicles for the purpose of delivering or collecting goods or loading or unloading a vehicle for a period of more than 40 minutes in the same place will be prohibited at the times and in the lengths of streets specified in Schedule 1 to this Notice;

(d) the sale or offer for sale of goods from a vehicle will be prohibited (except on Sundays) in the lengths of streets specified in Schedules 1 and 2 to this Notice, unless there is in force a valid licence issued by the Brent Borough Council or the goods are immediately taken into or delivered at premises adjacent to the vehicle from which the sale is effected;

(e) the use of any vehicle or of any animal or the wearing of fancy dress or other costume, wholly or mainly for the purpose of advertising will be prohibited in the lengths of streets specified in Schedules 1 and 2 to this Notice;

(f) any existing prohibition on the waiting by vehicles, the sale or offer for sale of goods from a vehicle or the use of any vehicle or animal or the wearing of fancy dress or other costume wholly or mainly for the purpose of advertising in the lengths of streets specified in Schedules 1 and 2 to this Notice will be revoked.

3. The prohibitions referred to in sub-paragraphs 2(a) to (c) inclusive above will not apply in respect of anything done with the permission or at the direction of a police constable in uniform or in certain circumstances, e.g., the picking up or setting down of passengers; the carrying out of statutory powers or duties; the taking in of petrol, etc., from roadside petrol stations; to licensed street traders, etc. The usual exemption relating to vehicles displaying a disabled person's "Blue Badge" will apply.




