Thank you for your letter of May 22nd.

As District Councillor for Harston and Hauxton, I wish to serve the statement of case as requested for the local inquiry.

I understand the necessity of closing the level crossing (though this does not have universal acceptance in Harston.)

However, the proposed public footpath diversion is not acceptable.

This is because:

- it is un-necessarily complicated and dangerous, crossing the busy B1368 road twice;
- it is not accessible to wheel chair users or push chairs, and difficult for bicycles as it involves steps up and down to the road-over-railway bridge.

The current public footpath is used as a leisure route for walkers and families, so these need catering for.

A route is suggested wholly on the south side of the B1368, using a ramp to access the bridge. I have received a number of emails from residents concerning this. Regards
