I am writing in connection with the South Tees Development Corporation "STDC" South Tees, Redcar regeneration scheme. You may already be aware of the scheme from recent press articles and TV coverage and you may have had previous correspondence and/or contact from STDC.

The STDC has ambitious plans and has developed a Master Plan which envisages the creation of a worldclass industrial park on the River Tees. The plan is aimed at enabling industrial investment that will create approximately 20,000 new jobs and contribute £1 billion per annum into the UK economy.

The STDC has advanced negotiations with the major landowners required to deliver the scheme but there are further land and property interests that are potentially needed to enable the scheme to go ahead.

This includes part of your leasehold interest CE149648 falling within Freehold Title CE175030.

STDC is currently preparing a compulsory purchase order for the whole of the scheme, which it will use to assemble the site only if it is unable to reach agreement with all of those affected.

I am writing in connection with the South Tees Development Corporation "STDC" South Tees, Redcar regeneration scheme. You may already be aware of the scheme from recent press articles and TV coverage and you may have had previous correspondence and/or contact from STDC.

The STDC has ambitious plans and has developed a Master Plan which envisages the creation of a world-class industrial park on the River Tees. The plan is aimed at enabling industrial investment that will create approximately 20,000 new jobs and contribute £1 billion per annum into the UK economy.

The STDC has advanced negotiations with the major landowners required to deliver the scheme and completed significant land purchases but there are further land and property interests that are needed to allow the scheme to go ahead, this includes your property interest(s).

It remains STDC's preference to acquire the remaining land and interests it needs by agreement, but as this might not be possible in every case, STDC has also decided to seek to use its powers of compulsory acquisition to acquire any land or interests that it cannot secure by agreement.

STDC will therefore shortly be making a compulsory purchase order for the whole of the scheme, which it will use to assemble the site only if it is unable to reach agreement with those affected. This will require the service of formal documentation on all affected parties.

The purpose of this letter is therefore to let you know that the formal notice will be served upon you shortly and to invite you to continue negotiations to see if we can agree terms that avoid STDC having to use compulsory purchase powers in respect of your land or interest.

The compulsory purchase process is complex and STDC are available to answer any specific queries you have and to work with you throughout the process to address concerns which may arise.

STDC is also keen to assist you with any relocation opportunities that you may wish to explore and I shall be happy to discuss this further with you.

If you have not already done so I recommend that you appoint a surveyor experienced in compulsory purchase to assist you. STDC will be responsible for the reasonable surveyor's fees paid by you as part of the compensation you will be entitled to if we can reach agreement.

Compulsory purchase specialist surveyors can be found on the Compulsory Purchase Association website: www.compulsorypurchaseassociation.org, or on the Royal Institution of Chartered Surveyors (RICS) website www.rics.org/uk.

We would welcome confirmation that the above represents a reasonable reflection of the key points from the meeting, and the immediate actions to endeavour to try and move forward to an in principle agreement, in the spirit of mutual co-operation. It would seem that the immediate priority issues are for Tarmac to review and update information on the site product, and STDC to consider and put forward possible relocation site opportunities. Once we have these, we might meet again.
