I have been in correspondence with Bridget Choo-Bennett at the Objection Management Team, regarding the above proposed reduction project and the subsequent new public footpath that would be created over our property.

As you will see below, I sent an email on 1 April 2017 to Laurie Edwards at Bruton Knowles, describing and explaining our concerns, I asked for a delivery receipt and a read receipt which was received by myself as read on 3 April 2017. So duly thought that this 'objection' was being dealt with.

We recently received notification from Bruton Knowles that access was being requested to carry out a topography survey, on our land, so the matter of my correspondence on April 1st was raised.

It seems that my email was not communicated to the relevant people, so we missed out on the objection period, which as you can appreciate, is not our fault. Therefore, I have been advised to contact you as part of the Orders Unit, even though the objection period has passed, so our concerns are formally aired through the formal route. My Wife and I are extremely disappointed that, we have made, in our opinion, the correct objections along the correct route, and we are always having to chase this matter for a resolution or further information.

This matter has been compounded with myself being diagnosed with a brain tumour and have subsequently just recently completed radiotherapy after an operation, which has taken priority over anything else.

I would like our objection to be taken seriously, as an addition of a public footpath, will have consequences on our well being and property value.

Also since this proposal came to light the village is due to expand with various building sites being proposed, not least 100 homes to side of our property, if the footpath was granted this will increase the footfall past our property immeasurably. As the inspector would have noted the footpath would pass within approx. 2 metres of our front bedrooms and lounge having a dramatic effect on our privacy, quality of life and saleability of our home.
