Hello again Amy,

Thanks for the helpful links, I have now accessed your site and downloaded the Revised Precautionary Method of Works.

The revisions are very helpful indeed but I hope you do not mind me making the following comments:

- The main text is absolutely fine and I would not require you to amend or alter anything there.
- The Schedule does need a little revision and we must find a way of ensuring that it is signed off by the relevant site manager, charge hand or other suitably authorised person dealing with the implementation of any works on the ground. We could simply add another column for a name, signature and date? I appreciate that you have Appendix E but I think that the Schedule itself needs to be repeated there to allow this to happen...
- The Species-specific Precautionary Methods are fine other than to confirm in these paragraphs that the pre-construction walkovers will be carried out by a Suitably Qualified Ecologist (it says this for some but not for others, notably Otter – a European Protected Species).

My comments on the Schedule at 4.1 are as follows:

- At S.01 Sea Wall: Otter deserves its own line! Also, in the third column, I think that you should add words to the effect of: *"See 3.2.5 "Overwintering Birds" above. There should be no physical works from November to March."*
- At S.07 Broomfield: Has this one now been removed, as it was one of the sites we looked at the other day? No problem if it has!
- At S.11 Leggetts: Please add Hedgehog.
- At S.12 Gooderhams: Please add Hedgehog.
- At S.18 Cow Pasture Lane: Please add Hedgehog.
- At S.21 Abbots: Although I didn't mention it in my earlier statements, I would be grateful if you could please add Hedgehog.
- At S.23 Higham: Please add Badger.

- At S.25 Cattishall: I don't think that Stag Beetle will be necessary here. I am very happy for you to keep it as other insect larvae are also valuable but we don't have any records for SB in this area.
- S.69 Bacton: I don't think that Stag Beetle will be necessary here. I am very happy for you to keep it as other insect larvae are also valuable but we don't have any records for SB in this area.

Finally, I am very happy for my name to be added (after your own team, of course) should you wish to put it in Appendix D "Contact Details". I will happily speak to any of your colleagues or contractors if they have an ecological issue that they wish to discuss.

My last comment is to apologies for the delay in responding to you this morning, I hoped for you to have had this by 10.00am but we have just returned to our desks after Endeavour House was evacuated – a drill, I think!

Subject to the revisions that I have set out above, I believe that the PMW is a sound and comprehensive document that will act as an excellent mitigation strategy for this proposal and, with those final revisions resolved, I cannot see any circumstances in which I would withhold my approval and will be very happy for a dated version to be conditioned as part of any Order made.
