The Network Rail (Suffolk Level Crossing Reduction) Order Level crossing: S12 Gooderhams

We write to confirm that with regard to crossing S12 Gooderhams, Network Rail intends, if the Order is made, to implement the proposals as they have been submitted with the original application and shown on Sheets 17 and 18 of the Order plans and described and shown on Design Freeze plans (at tab NR12 Folder 01 of the application documents).

These proposals remain unaffected by the proposed modifications to the Order and plans as notified by Network Rail to the inquiry on 13 February 2018.

Suffolk County Council has confirmed that it does not object to Network Rail's proposals for this crossing. Although the Council has previously requested a westward footpath link to the Wassicks Crossing (Public Footpath 18 Bacton), Network Rail understands that the Council has confirmed that it is not intending to promote an alternative route to that proposed by Network Rail.

We understand that in light of this confirmation you would be willing to withdraw your objection to this crossing (S12) and we would be grateful to receive a copy of your correspondence with the TWAO Orders Unit confirming this. You have informed us and we acknowledge that you wish to maintain the remaining objections to the Order as set out in your letter of objection dated 4 May 2017 (Obj/26).
