One question that I wish to raise is about the removal of protecting WHISTLE boards from Weatherby crossing, that were still in place in 1990.

I also wish to query Network Rail's on-the-ground disability policy at pedestrian foot-crossings, citing several in Suffolk listed for closure (and the next-foot crossing along from Weatherby) which have been beautifully repaired and updated in very recent years, but that even though effectively brand-new constructions, do not conform to the provisions of the 2010 Equality Act, which I consider to be an unavoidable legal obligation and wish to hear any NR counter argument for non-compliance - including those of cost or space - and whether such avoidance is allowable under the Act.
