We note your comment at para 2 of your email below with submissions sent on Friday 11 May, that the agreed statement regarding diversion distances at S25 had not been received by St Edmundsbury BC and is still outstanding.

It is our understanding that Ms Tilbrook and Mr White had discussed the matter and agreed the distances, noting that they picked different starting points. Ms Tilbrook drafted the note based on that discussion and concluded that "both parties can agree that the maximum diversion distances are very similar and a figure of 1000m can be taken for the local diversion length, with the acceptance that the additional distances for wider origins and destinations will vary" – see para 10 of the attached note.
