Hi Chris,

Many apologies for the delay – previously all correspondence had to go through Network Rail but we have now agreed that I can continue my direct contact with yourselves.

Please find attached the correspondence from the EA regarding the sites in Cambridgeshire.

In addition please see an additional response from our flood risk team which expands on the points from the EA.

It is noted that a Public Right of Way (PRoW) is a route that anyone has a legal right to use on foot (or by certain modes of transport), they are, however, not considered Essential Infrastructure when considering flood risk. Only Essential Infrastructure (such as major evacuation routes) are required to kept safe and accessible during times of flood. PRoWs are legally required be kept free from obstructions, however, this does not extend to a natural obstruction such as a flood. If the path becomes blocked by a natural obstruction (e.g. during a time of flood) then the user does not have the right to deviate around the natural obstruction and is advised to retrace their steps and contact their local Countryside Access Team.

The Environment Agency (EA) note that PRoWs are classed as 'Water Compatible' and are therefore acceptable within Flood Zone 3b – the functional floodplain. If a PRoW could be affected by flooding then public safety notices are an option to consider. From an historic flooding perspective, it is unlikely that the EA hold any information about the frequency of flooding in this location as it is located within the raised flood defences. The EA would only record flooding if these defences were overtopped or breached.

With regards the ecology surveys, these are currently ongoing as access has been difficult to obtain for third party land but I have made contact with Julia Beeden in CCC and Beth will be in touch shortly with a summary of the survey results. I know surveys have been undertaken at C16 &C17 so hopefully we can provide a summary of those by the end of the week.

Please can you confirm that the only outstanding data from myself now is the ecology survey results for the sites that CCC refer to in their objection letter?
