		Damage to public byways is a regular source of concern to land managers and the public alike. Damage is frequently caused by anti- social use by off roaders.					
		Policy – 'Making the best of byways', published by Defra in 2005, still has relevance to byway management and SCC will have regard to it when responding to damage to byways.					
		Action – SCC will work with user groups to deter anti social use and take a proportionate approach to byways maintenance. Where damage by public vehicles cannot be repaired at reasonable cost, SCC will consider restricting or prohibiting access to those types of vehicle causing the damage. Access will only be restricted where there is evidence of a pattern of misuse.					
4.	(Severance)	Vulnerable highway users, eg walkers and cyclists, face difficulties when their journeys make use of both PRoW and busy roads. This point was also picked up in consultation responses.

4.	Open Access	There are c.5000 ha of open access in Suffolk, which the public have a right to access on foot. This is mainly heathland and there is about the same amount of forestry land where the public have similar rights. This is a valuable recreational resource which must be balanced with the needs of conservation. This done mainly through seasonal restrictions of access.					
		Policy – SCC will continue to work with Natural England, land managers and communities to manage open access and to dedicate new areas of open access, where there may be a public benefit.					
		Action – SCC will continue to work with Natural England, the local access forum and land managers when restrictions are reviewed. SCC will seek to ensure the reasons for imposing a restriction are valid.
