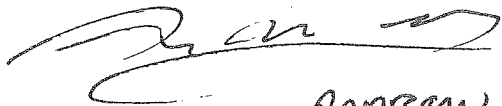

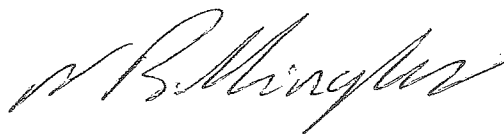

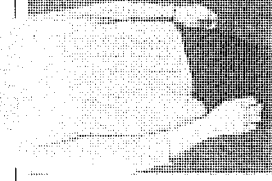

Racing charity targets 'social epidemic' of isolation

Be Friendly scheme to help tackle loneliness

As the government appointed a minister to help tackle the loneliness suffered by an estimated nine million people across the country, Newmarket-based charity Racing Welfare has launched its own initiative to help racing staff cope with what has been called a 'social epidemic'.

The new service has been named Be Friendly after the dual Haydock Sprint Cup winner owned by the late Sir Peter O'Sullivan, a long-standing supporter of the charity.

It is part of Racing Welfare's wider campaign to reduce social isolation and loneliness within the horseracing community, specifically those re-

tired from the industry.

"The charity is aware that it can be a major contributory factor leading to serious health problems and therefore runs a programme of coffee mornings, outings and holidays for people who have retired from the racing industry," said charity spokeswoman Rachel Cawley.

The Be Friendly service is aimed at helping those from the horseracing industry who are either elderly or incapacitated and could find themselves isolated in their homes.

The helpline will be making calls on a regular basis to people, not only to have a chat but also to ensure that everything is okay.

Anyone who would like to sign up to the Be Friendly service, which is free and confidential, can do so by calling Racing Welfare's 24-hour helpline on 0800 6300 443.

Simone Sear, the charity's director of welfare, said "It is really fitting to be able to name this important new service after one of Sir Peter O'Sullivan's most notable horses.

"Racing Welfare has received more than £250,000 from the Sir Peter O'Sullivan Charitable Trust in the past five years alone. It is a vital contribution to ensure Racing Welfare can maintain and develop its services to support racing's people."

Nigel Payne, for Sir Peter's charitable trust, said: "Racing Welfare was one of Peter's six favourite charitable causes and the trust continues to support their work.

"Peter would be chuffed to bits to have Be Friendly recognised in this manner."

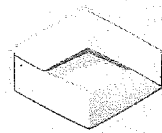
Minister signals support for Soham

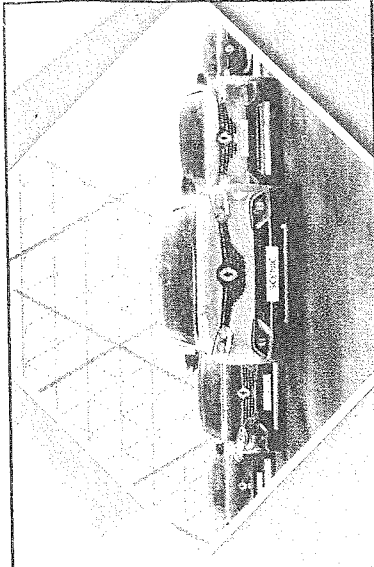

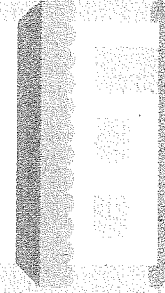

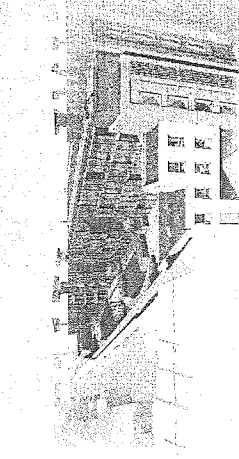

West Suffolk Hospital has apologised and is investigating the incident.

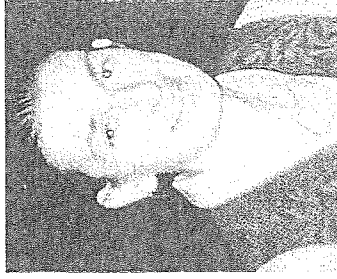

Bury man admits fatal stabbing

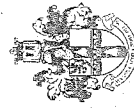
A man suffering from a mental illness has admitted stabbing another man to death in Bury St Edmunds.

Sizewell C will bring '£200m economy boost'

Chiefs say power station 'must be built in Suffolk'

Energy bosses have outlined the huge benefits a new nuclear power station could bring to Suffolk - and say it will be a "missed opportunity" if it is not built.

Executives at EDF Energy estimate that the 10-year construction of Sizewell C could inject around £200million a year into the area's economy.

They believe this will happen even though the cost of the £16billion twin reactor is expected

to be 20% less than first expected. On a visit to see the progress on the £20bn Hinkley Point C (HPC) complex, EDF Energy chief executive said Sizewell C could be cheaper because the site has a grid connection capable of handling a bigger power station which could mean "substantial savings".

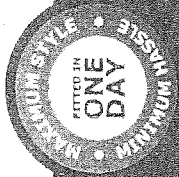

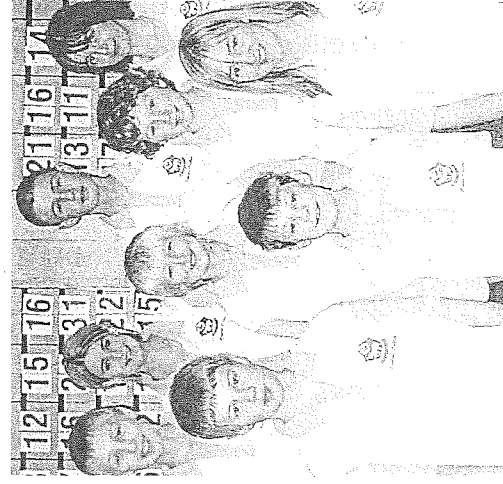

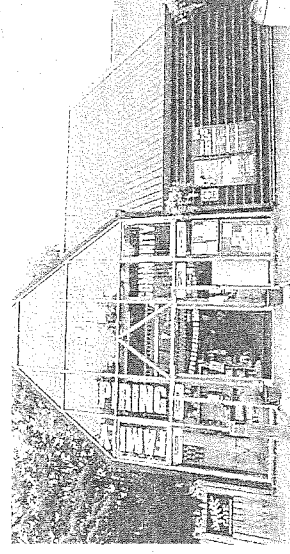
