Good afternoon Mr. Doran,

Thank you for your prompt reply.

I would be grateful if you would enquire. Even if the incident was minor and unreported, it would be useful to know if it happened.

The reason is that tomorrow a public inquiry into the closure of level crossings by Network Rail will examine the case for closing the Paget Rd Wivenhoe crossing. Part of NR's case is that there are alternative routes. One of them being via Queens Rd and Anglesea Rd. Clearly if a CBC employee has slipped on loose shingle at that junction, then it is hardly safe.
