I would be grateful if you would distribute these Summary Sheets internally only until the day of the consultation events.

As you will see from the Round 2 public consultation material we have tried to accommodate your suggestions where appropriate. We are just in the process of finalising the minutes from our workshop on the 5/8 and will issue shortly for your comment.

You have previously been sent the summary report on the Round 1 consultation questionnaire responses (please find attached again for your convenience). We are in the process of reporting back on additional non-questionnaire responses to Round 1 public consultation which have fed into the option development and appraisal process: this was mainly via emails to the project inbox, and we will provide further commentary on this shortly.

We have now completed 2 rounds of RSA and the documents are attached for information. These were undertaken by an independent team and we are currently drafting a single consolidated (for 2 rounds of RSA) Designer's Response; some issues have led to design changes, for others we'll clarify the situation. Therefore the Designer's Response will be the most useful document and we'll be issuing it to Network Rail shortly and hope to share it with you in due course. Please note that these, along with any other document we send you are confidential and not to be distributed to other parties.

We'd previously shared the three day census results with you and have agreed with Network Rail that the remaining six days will be transcribed. Our contractor is currently in the process of analysing the data and we will share this with you when available which should be in the next month.

As discussed previously Motts will discuss the proposals with you and present the results of the Round 2 public consultation however given return period this will be from week commencing 31<sup>th</sup> Oct so <u>please would you let me</u>

know your team's availability. However to help expedite things we are willing to offer an interim meeting in the first week of October to talk through the proposals including your thoughts on the Round 2 Summary Sheets if you feel that would be helpful and your team is available.
