I all writing to inform you that I DON I OBJECT TO THE PROPOSED CROSSING OVER THE AZI.
I have been involved with farming since 1958 in the Rother Valley and my parents farmed there since 1947.
There were always various branch lines running from the Quarries in Mountfield and also running to Hodsen's Mill in Robertsbridge until lines were closed and transport was lorry freight
The Environment will not be affected by steam trains ctossing the A21, and no extra flood risk. Already flooding has increased because of more houses built and inadequate infra structure to support the building increase. It is to be noted that the Environment Agencies do not have the finance to clear the rivers out periodically to improve water flow nor check permanant fixtures built on the flood plains so causing water retention and back log of water flow which regularly affects Etchingham, Robertsbridge, Bodiam, Newenden and further on. The Rother being tidal, affects this also. These WATER MEADOWS (flood plains) are in Parish Papers since 1450 and have always coped with water dispersal in a natural unfettered manner. Banking buffers/ supports of the rails and the crossing will not add extra retention of water as adequate undercut ditches will be installed.
Mountfield crossing is well used by traffic and there is no unusual congestion with traffic buildup and in fact slows vehicles as drivers are aware of the high speed movement of trains crossing there Traffic on Robertsbridge Bypass already drive too fast and take dangerous overtaking manoeuvers down towards the roundabout and then up Silverhill Road, towards Hurst Green, if being held up by heavy freight. Perhaps the knowledge that there is a crossing will improve speed control.
This extension of the the train route from Tenterden to Robertsbridge will improve Trade and Tourism to surrounding villages including Robertsbridge and also increases Employment and added Education Development
This will improve hus/seach connections and involvement is Coach Tours for Home and visiting Tourist Coaches

To whom it may concern.
I am writing to inform you that I DON'T OBJECT TO THE PROPOSED CROSSING OVER THE A21.
I have been involved with farming since 1958 in the Rother Valley and my parents farmed there since 1947.
There were always various branch lines running from the Quarries in Mountfield and also running to Hodsen's Mill in Robertsbridge until lines were closed and transport was lorry freight
The Environment will not be affected by steam trains ctossing the A21, and no extra flood risk. Already flooding has increased because of more houses built and inadequate infra structure to support the building increase. It is to be noted that the Environment Agencies do not have the finance to clear the rivers out periodically to improve water flow nor check permanant fixtures built on the flood plains so causing water retention and back log of water flow which regularly affects Etchingham, Robertsbridge, Bodiam, Newenden and further on. The Rother being tidal, affects this also. These WATER MEADOWS (flood plains) are in Parish Papers since 1450 and have always coped with water dispersal in a natural unfettered manner. Banking buffers/ supports of the rails and the crossing will not add extra retention of water as adequate undercut ditches will be installed.
Mountfield crossing is well used by traffic and there is no unusual congestion with traffic buildup and in fact slows vehicles as drivers are aware of the high speed movement of trains crossing there Traffic on Robertsbridge Bypass already drive too fast and take dangerous overtaking manoeuvers down towards the roundabout and then up Silverhill Road, towards Hurst Green, if being held up by heavy freight. Perhaps the knowledge that there is a crossing will improve speed control.
This extension of the the train route from Tenterden to Robertsbridge will improve Trade and Tourism to surrounding villages including Robertsbridge and also increases Employment and added Education Development
This will improve bus/coach connections and involvement i.e.Coach Tours for Hams and visiting Tourist Coaches.
It is a shame that there is a huge publicity campaign to be Negative about what potentially could be a Positve, Productive and Enhamcing Project with , if approached properly, be Productive to All.
