3. **Rule 13(1)** requires the applicant to serve a copy of the application and every document accompanying it on every local authority in whose area a transport system, inland waterway or other works to which the application relates is or are to be situated and deposit copies with the library in in the House of Commons and the House of Lords.

For compliance with this Rule, notices were served in the form prescribed on 19 April 2018. Details of the recipients of this notice are set out in the affidavit of David Gillett which can be found at **TAB 3**.

4. **Rule 14(1)** requires the applicant to publish a notice in the London Gazette which shall:
 - (a) state the name of the applicant and the address given pursuant to rule 9(2);
 - (b) state to whom the application has been made;
 - (c) state whether the application is subject to an environmental impact assessment;

- (d) summarise the main proposals and specify the location of the proposed works (if any); and
- (e) state the address to which objections or other representations are to be sent and the expiry date for objections.

Notice was published for compliance with this Rule in the London Gazette on 19 April 2018. The form of this notice as published can be found in the affidavit of David Walker at **TAB 4**.

- 5. **Rule 14(2)** requires the applicant to publish in a local newspaper circulating in the area (or each of the areas) in which the proposals contained in the application are intended to have effect, a notice in the form of Form 1 in Schedule 2 to the Rules on 2 separate occasions, the first publication to be not more than 14 days before, and not later than, the date of application and the second to be not more than 7 days after the date of application.

The form of this notice as published can be found in the affidavit of David Walker at **TAB 4**.

- 6. **Rule 14(10)** requires the applicant to supply a copy of the application, or of any document that these Rules require shall accompany an application, to any person who requests such a copy, subject to the payment by that person of a reasonable charge for the provision of that copy, and the applicant shall ensure that information as to how such copies may be obtained is displayed at every place at which copies of the application and those documents are made available for inspection.

A notice stating how documents can be obtained was displayed at every deposit location from 19 April 2018. A copy of this notice can be found at **TAB 5**.

- 7. **Rule 15(1)** requires the applicant to serve a notice in the form of Form 5 in Schedule 2 to these Rules upon all those, other than the applicant and the owner of any Crown interest, named in the book of reference.

Rule 15(2) requires that in every case where, pursuant to rule 12(10), the applicant has indicated in the book of reference that relevant names have or might have been omitted, he shall, forthwith after the application has been made, serve a notice in the form of Form 5 in the manner provided by section 66(4)(a) and (b) of the Act (unknown owner notices).

On 19 April 2018 notices were served in compliance with Rule 15(1) and where applicable unknown owner notices were placed on site in compliance with Rule 15(2).

The notices were served on all those listed in the Book of Reference in accordance with Rule 12(8) and subject to Rule 12(10)

- 8. **Rule 10(8)** requires that, as soon as practicable after the date of an application, the applicant shall submit to the Secretary of State evidence by affidavit of compliance with the provisions of rules 13 (specifically Rule 13(1), the deposit of the application documents with every local authority affected by the scheme, and deposit of the application documents in the House of Commons and House of Lords, and Rule 13(3), the deposit of application documents with the relevant bodies listed in Schedule 5 of the Rules) 14(1) to (8) and 15, and shall exhibit to any such affidavit copies of notices placed in newspapers and the London Gazette (and Lloyd's List if applicable) in accordance with rule 14.

9. On 8 June 2020 the Inspector for the Public Inquiry into the TWAO made a direction under Rule 17 requiring the submission by the applicant of certain further environmental information including a new Flood Risk Analysis.

As a consequence of the coronavirus pandemic, the Secretary of State directed the Applicant not to comply with the usual requirements of Rule 17(4) and no hard copies of the further environmental information were made available for inspection. Hard copies of the information could however be obtained by contacting the applicant by telephone or email.

On 8 March 2021 the applicant wrote to all the parties who were served with the statement of environmental information submitted with the original application informing them that the Department for Transport advised that the documentation may be made available in an electronic format only, by uploading the information to the Inquiry website and that they would make hard copies of all or part of the material available to anyone entitled to a copy under Rule 17 who requests it (at a reasonable charge to cover printing and postage costs).

Notice of the submission of further environmental information was published in the Rye & Battle Observer on 5 March 2021. A copy of the form of the notice as published is at **TAB 8**

10. Rule 13(6) of the Inquiries Rules requires that the applicant shall not later than 2 weeks before the date fixed for the commencement of an inquiry—
- post a notice of the inquiry in a conspicuous place or as close as reasonably practicable to, the land to which the powers sought in the application relate;
 - post a notice of the inquiry in one or more places where public notices are usually posted in the area in which the proposals contained in the application relate;
 - publish a notice of the inquiry by local advertisement in the area in which the proposals contained in the application are to have effect.

For compliance with Rule 13((6)(a) notices were displayed along the route on 20 June 2021 16 days before the start of the inquiry. A copy of the notice (being the second newspaper notice referred to below) can be found at **TAB 9**.

In relation to Rule 13((6)(b) notice of the inquiry was displayed on Rother District council's notice board outside the Town Hall, London Road Bexhill on sea TN39 3JX and also placed on the council's website from 11 June 2021.

In addition Salehurst & Robertsbridge parish council displayed the notice on its parish notice board.
