1. RVR 19 Consultation

Mr Richard Turney referred me to the attached Report on Consultation document as regards my comment that I was disappointed that the Applicant had not consulted with Hastings Chamber of Commerce.

Looking at the attached document, paragraph 3.2 states that a presentation was made to Hastings Business Forum. Appendix 15 indicates 25 March 2015 as the date the presentation to Hastings Chamber of Commerce. I would like to note that a presentation is not a consultation. What was presented? Were details of a level crossing over the A21 given?

In addition, I note that at paragraph 4 detailing the responses to the consultation, there is no apparent response from Hastings Business Forum or Hastings Chamber of Commerce - whichever organisation the presentation was made to.

I also note that in Appendix 2 Schedule of Stakeholder Consultation, Hastings Borough Council was not consulted, nor the MP (or candidates) for Hastings and Rye Constituency, which surprises me.

I am doubtful that the extent of consultation with Hastings and Rye has been sufficient.
