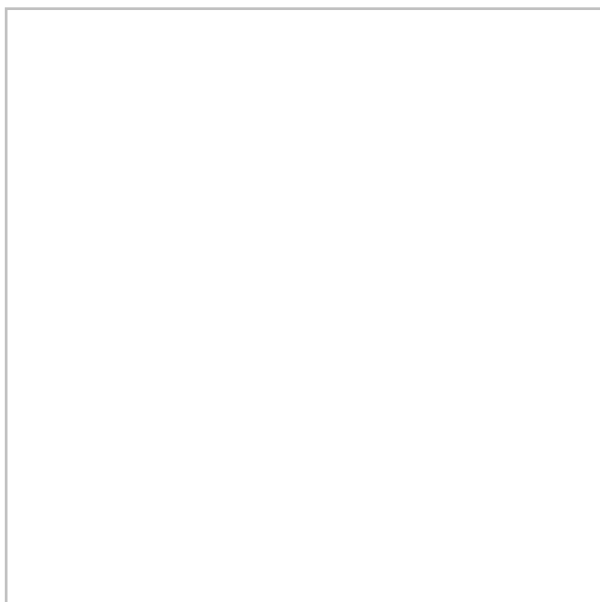

I wrote to you previously advising you of an appeal we had received. At that time I explained that the appeal was to be decided by the 'Inquiry procedure' and that we would contact you when we had further details of the date and venue of this Inquiry.

I can confirm that the Inquiry will commence at 10 o'clock on Tuesday 20 July 2021 and will be held at the Town Hall, New Council Chamber (Old

Town Hall Entrance), Walliscote Road, Weston-super-Mare, BS23 1UJ.

The Inspector appointed to decide the appeal is Phillip Ware BSc(Hons) DipTP MRTPI, assisted by Claire Searson MSc PGDip BSc(Hons) MRTPI IHBC and Dominic Young JP BSc(Hons) MA MRTPI MIHE. The Inquiry is scheduled for 40 sitting days.

We anticipate a high level of public interest in the inquiry, however the capacity of the venue is limited. Please note that due to the ongoing Covid-19 pandemic and social distancing measures that remain in place it has been agreed with the Planning Inspectorate that members of the public are strongly encouraged to view the inquiry online and not attend in person. Although members of the public do not have a legal right to speak at an inquiry, the Inspector may make arrangements to allow you to do so provided you have let them know in advance. If you want to speak at the inquiry, it is important that you contact the programme officer ([Joanna Vincent](#)) for further information.
