Firstly congratulations on your promotion to Interim Chief Executive – we wish you well in that role.

You'll recall we had a useful discussion last year in which you reported as per below that there was support for the idea of scrutiny over at least some aspects of the airport operations. We later had a request for input on parking issues but were then advised that the meeting had been cancelled.

I'm not sure what the status of this initiative is, and wondered if you'd be kind enough to further update us?

It would also be useful to have some clarity regarding where LBC's scrutiny of noise in relation to the planning conditions begins and ends, since as you're aware it has been clear for some time that the airport would be in breach of its noise contours, yet it appears that the Noise Control Scheme was signed off not long before that breach occurred?
