Introduction

We've committed to aiming for net zero carbon in advance of the national target in 2050. This plan describes the actions we will take to consolidate and accelerate what we are already doing, identify and analyse gaps and to initiate a borough wide debate on the scale and pace of change that is required.

We've made significant progress in reducing carbon emissions in the recent years by:

- reducing energy use
- improving the energy efficiency of our corporate buildings and social housing stock
- investing in renewable technologies
- promoting sustainable transport in the borough and beyond

We've also influenced and encouraged action in the community though our longstanding fuel poverty agenda. However, to achieve the 2040 target we will have to go further.

The actions listed in our plan below set out the initial opportunities we've identified to reduce carbon emissions and increase carbon sequestration relating to the council's operations, but this is only a starting point.

We'll engage staff, contractors and anchor organizations in town and the entire community to expand the plan and the range of actions that help us to meet our target.

This plan does not describe how the borough as a whole will reach carbon neutrality. Along with our partners, residents and businesses, we all need to work together to achieve this broader goal.

Therefore we'll hold a citizen's assembly and process of stakeholder engagement to agree how we will achieve this ambition. However, we're already looking at how we can use our powers to help Luton transition to a low carbon future.

We're in the process of reviewing our Local Transport Plan and are about to start a review of the Local Plan. We anticipate that these plans will set out how we will:

- improve public transport
- improve walking and cycling infrastructure
- improve local environmental quality
- put electric vehicle infrastructure in place

Our Local Plan review will consider exacting environmental standards for new developments:

- by setting parameters for zero carbon development
- with significant improvements in air quality in the borough

In addition, the Local Transport Plan will be aiming to increase sustainable transport modes:

- through appropriate parking standards (including cycle parking) in new developments
- facilitating electric vehicle charging and car club provisions wherever possible

The impacts of these plans are not covered in detail here, but will be reflected in the borough wide carbon reduction plan that we will develop with residents, businesses and partners over the next year.

Action plans

This action plan describes the actions we'll take to reduce carbon emissions. It also includes actions relating to our governance, procurement and investment to improve the consideration given to the carbon impact of the decisions we make.

Comments:

- We're currently in year 2 of a relighting programme to change all our discharge lights into LED, some involve new columns
- looking at year 3 now which will involve many more of the main roads to date the programme has been around residential roads
- expect the current programme to be completed by December
- assess available budget we've been offered SALIX funding but Finance have been slow on the approval, we do want it as it will allow us to complete the whole borough next year (2021)
- Year 2 was completed in February with a full budget, internal, not SALIX, for 2021-22 of £2.25m.
- change some Parks Lights to LED, mainly the less efficient ones and some that are on the CMS

- consider replacement of bowling greens with artificial surfaces to reduce maintenance and water consumption.
- Increase the tree canopy across the whole Borough
- Re- wilding the town

- 6 additional strimmer/brushcutters, 4 additional Blowers, 2 additional Hedge cutters
- working with procurement undertaking a soft market testing exercise to establish a specification to tender a contract for developing the use of zero emission robotic mowing solutions.
- meeting schooled with property and construction to look at the parks estate.
- currently present at some sites, though no further development planned for 2020 until discussions have taken place with allotment associations
- plans are being devised for consultation with community groups about the future management of sites.
- consultation has commenced with regards CAT transfer of greens to clubs. Two bowling
 greens have closed due to clubs folding therefore maintenance and water consumption
 reduced by 40% (five greens reduced to three) alternative use being identified for closed
 sites. Robotic mower zero emissions being trialled to maintain closed sites.
- achieve the target of 1ha increase in canopy will require retention of existing canopy through good management and resisting requests for removal due to non- actionable nuisance issues & Securing funding for tree planting (internal and/or external)
- the baseline is 66 hectares of tree canopy cover
- a Luton Tree Policy and Tree Management Strategy for 2020-2030 is currently being drafted for adoption
- this canopy be monitored through a five yearly i-tree eco audit of our tree stock
- no loss of canopy cover in years 1-5
- increase of 0.25ha in years 5-10 (based on numbers of trees planted and their potential canopy at full maturity)
- increments of 0.25 ha every 5 year thereafter (based on numbers of trees planted and their potential canopy at full maturity)
- reduce cutting frequency, reduces vegetation growth and the resulting management burden, improves the natural capital value in particular the number and diversity of flowering plants and a reduced carbon footprint.
- initial trial commenced 2020 and is being reviewed/extended

2. Homes

Action summary: Current council housing stock

Council team: BTS

- provide reasons and assessment on why all council homes are not EPC C or better
- develop a programme of LED light installations in all communal areas
- consider installing heat pumps into all communal areas of sheltered schemes
- develop non-gas heating solutions prior to statutory requirement coming into force

- currently 82% of council homes are EPC rating C or above
- RENEW £6m ERDF match-funded project for cladding of high rises in Marsh Farm
- 30 communal sites through the borough has access to LED lighting
- over £200k has been spent by BTS on LED lighting
- currently 15 communal sites have access to heat pumps as secondary heat source
- currently 184 properties (2.6%) have access to electric storage heating
- LADS phase 2 application to be made for installation of insulation and renewable heating options in stock
- £650k allocated to Luton via the LADS2 scheme

3. Transport

Action summary: Sustainable transport

Council team: Strategy & Sustainability/ Highways

More information:

- continue to encourage the use of public and active transport cycling, walking and scooting
- ensure active travel is prioritised when designing local highway improvements
- introduce a Work Place Parking Levy to secure investment in sustainable transport

- see LTP sections implementing infrastructure and 'softer' measures (travel plans etc) to encourage behaviour change - these are covered in the following sections of draft LTP
- alternatives to private vehicle use: walking and cycling
- supporting communities to change unhealthy (or health limiting) behaviour is a key aim of this Transport Strategy:
 - promoting and making it easier to undertake active travel and leisure will make a significant positive contribution to people's physical and mental health and well-being
 - active travel also plays a part in reducing vehicular emissions, so we'll encourage cycling and walking as a sustainable way to travel

- we'll promote the health benefits that can be delivered through an increased take up of these modes, particularly for shorter distances of up to 5km
- in addition to lowering emissions, there are a range of other benefits including increased social interaction, supporting local businesses, promoting a vibrant town centre and providing a high-quality and appealing public realm
- based on the criteria set out in Table 1 of the DfT's guidance on the 'New Powers and
 Opportunities of the 2017 Bus Services Act', the soard suggested the following priorities for
 improving bus services:
 - o first Better places
 - o followed by Better buses
 - third, Better value for new forms of mobility which includes e-scooters (including as one stage in a longer journey) - see section 7.5 of the LTP4
- A proposal to develop business case (including consultation with business community was due to go to Exec in Spring 2020 but was pulled because of Covid19
- on hold

- investigate options to increase the number of cycling trainers and extend the cycling training provisions to secondary schools and adults
- continue engagement with the local cycling forum
- continue partnership working at regional level (Cycle Hub East of England) and national level (Sustrans, Bikeability Trust)
- investigate new funding mechanisms for cycle training and support for the award winning bicycle recycling scheme

- recruitment freeze has stopped us from being able to expand the team at this time once we're able to recruit we'll investigate expanding the cycle training delivery
- due to Covid 19, the cycle form are not meeting however we've maintained contact via email
- East Region RDC (regional)
- funding options where investigated pre Covid 19 following the lockdown these sources are no longer available so alternative options will be looked for
- continue 'Dr Bike', a Luton Council operated, free of charge, bike servicing scheme operating outside of Luton train station

Comments

We'll carry out the following actions in order to promote and encourage use of ultra low emission and electric vehicles.

- 1. Increase the provision of electric charging points across the borough
- 2. As part of our efforts to promote sustainable and low emission transport options, a series of electric vehicle pop-up information events will be coordinated to create a place where people can:
 - a. find out more about electric vehicles
 - b. have a look at some of the models available first hand

These sorts of events have been run in several London boroughs as part of the mayor's Air Quality Fund objectives, and have proven successful in spreading greater awareness and understanding of electric vehicles amongst local residents and businesses.

3. Over the past two years, residents of Luton have made over 500 bookings, and travelled over 45k unpolluted, miles through the e-Car club.
