**THE NETWORK RAIL (OLD OAK COMMON GREAT WESTERN MAINLINE TRACK ACCESS)
ORDER 202[]: OBJECTION (REF:TWA/21/APP/01/OBJ/8) (the Objection)**

We write further to your letter dated 6 June 2023 which acknowledges receipt of the Objection to the draft Network Rail (Old Oak Common Great Western Mainline Track Access) Order 202[] (the **draft Order**) we submitted on behalf of our clients, Bellaview Properties Limited (**BPL**).

As stated in the Objection, BPL is the freehold owner of land known as 239 Horn Lane, London W3 9ED and registered at the Land Registry under Title Number AGL22605 (the **Property**). The Property is the subject of the proposed exercise of compulsory purchase powers pursuant to the draft Order. BPL is therefore a statutory objector within the scope of section 11(4) of the Transport and Works Act 1992 (the **Act**).

As requested in your letter (paragraphs 4-5 of your letter), we confirm that BPL wishes to exercise its right to have the Objection referred to a public inquiry and appear and be heard at the inquiry pursuant to section 11(2) of the Act.
