CITY AIRPORT DEVELOPMENT PROGRAMME (CADP) APPLICATIONS 13/01228/FUL (CADP1) &
13/01373/OUT (CADP2)

I refer to the above planning applications submitted on 26 July 2013 on behalf of London City Airport. Since the submission of the applications there have been discussions with LB Newham, the GLA, TfL and others about the proposals. The applications were also subject to an extended consultation period which formally closed on 18 December 2013.

On 21st January 2014 the Borough Council wrote to the Airport seeking further environmental information and clarifications focusing mainly on design, sustainability and energy, construction, noise, air quality, transportation and climate change.

We note that the design of the CADP proposals has been well received during the ongoing discussions, and accordingly the proposed changes are relatively minor in nature. Organisations have also voiced their support of the proposals including, but not limited to, RodMA, ExCel London, Newham Chamber of Commerce, London Chamber of Commerce, London First and Canary Wharf Group. The objections to the proposals have also been carefully considered and the CADP project has looked to respond positively to these wherever possible.

Having regard to comments received, minor design refinements are proposed to the detailed application relating to passenger facilities and infrastructure (LPA ref. 13/01228/FUL) (CADP1). No

changes are proposed to the related outline application proposal for the hotel (LPA ref. 13/01373/OUT) (CADP2).

Accordingly, I enclose 3 copies of the following as an update to the CADP planning submission, which should be read in conjunction with the submissions made in July 2013:

1. **Revised application drawings.** These relate to a limited number of application drawings that are updated following the minor design refinements. Annex 1 to this letter comprises a revised drawing list relating to Application CADP 1 (ref 13/01228/FUL) and clearly indicates where drawings have been updated. As explained, no changes are proposed to the outline application for the proposed Hotel (CADP2).
2. **Design and Access Statement Addendum.** This documents LCY's response to design matters raised since the applications were submitted, particularly those raised by the LB Newham's Design Review Panel Chair workshops, and the GLA in respect of its design comments on the Forecourt.
3. **Environmental Statement Addendum with updated Non-Technical Summary (NTS).** This focusses on, and responds directly to, those items raised by the LB Newham in their request for further information under Regulation 22(1) and 22(10) dated 21st January 2014, as well as other environmental issues raised during the consultation process. Where appropriate, changes to the environmental impact of the development have been assessed in addition to further environmental requirements raised by the LB Newham to enable the scheme to be robustly assessed under the Environmental Impact Assessment Regulations. Throughout the Addendum, a clear distinction is made between clarifications and further information. For clarity and ease of reference an updated NTS is also provided with the updates clearly identifiable through tracked changes.
4. **Energy and Low Carbon Strategy Addendum.** This responds directly to comments received from the GLA in their Stage 1 Consultation Response to the CADP.
5. **Planning Statement Addendum.** This explains how the CADP proposals have been modified in response to comments made, the design development, and clarifies details provided in the July 2013 submission. In particular, the Addendum focuses on planning issues not covered in other documents which have been raised by Planning Authorities, statutory consultees, interest groups and others during the consultation process.

In accordance with Regulation 22(3) of the Environmental Impact Assessment Regulations we understand that the Council will undertake further consultations on the revised proposals.

Additional copies of the Environmental Statement Addendum and Technical Appendices can be provided at a cost of £30. Alternatively a CD-ROM version is available for an administrative charge of £15 (including postage and packing). The NTS can be provided free of charge upon request as an electronic or hard copy. All Environmental Statement documents are available from: RPS Planning and Development, 14 Cornhill, London, EC3V 3ND.

Fundamentally, the principles of the CADP proposals remain the unaltered and will:

- Enable the Airport to respond to forecast growth in passenger numbers (particularly at peak periods) and accommodate larger, quieter and more fuel efficient new generation aircraft;
- Make better use of the existing runway in accordance with national policy;
- Provide circa £200 million of inward investment into Newham which complements the regeneration of the Royal Docks and delivers around 1,500 new jobs; and
- Make no change to the consented number of flights or opening hours of the Airport.

We look forward to discussing the progress of the application with you in due course.
