We hereby certify in relation to the above Order that:

- 1. The made Order was submitted to the Planning Casework Unit under cover letter dated 14 February 2023 (a copy of the cover letter is at **tab 1**).
- A draft of the General Certificate was submitted to the Planning Casework Unit under cover letter dated 14 February 2023 (as noted above, a copy of the cover letter is at tab 1). The final version of the General Certificate (copy at tab 2a) was submitted to the Planning Casework Unit electronically via email on 30 March 2023 (copy at tab 2b).
- 3. The Protected Assets Certificate dated 8 February 2023 (copy at tab 3) (amongst other documents) was submitted to the Planning Casework Unit under cover letter dated 14 February 2023 (as noted above, a copy of the cover letter is at tab 1).
- 4. Notice of making the CPO was:
 - 4.1. Served on all qualifying persons in accordance with Section 12(1) of the 1981 Act (a copy of the notice is at tab 4a and the covering letters at tab 4b). The time allowed for objections (which was not less than 21 days) was 8 March 2023. The notices were served by one or more of the methods described in Section 6(1) of the 1981 Act.
 - 4.2. In relation to land in unknown ownership, a notice was served by one or more of the methods described in Section 6(4) of the 1981 Act (a copy at tab 5a and the covering letters at tab 5b). The time allowed for objections in each of the notices was not less than 21 days and the last date for them was on 8 March 2023.
 - 4.3. Published in the local newspaper the Enfield Independent on 8 February 2023 (copy at tab 6a) and 15 February 2023 (copy at tab 6b and 6c), in accordance with Section 11(1) of the 1981 Act. The time allowed for objections was not less than 21 days from the date of the first publication of the notice and the last date for objections was 8 March 2023.
 - 4.4. Affixed to conspicuous objects on or near the Order land in accordance with Section 11(1) of the 1981 Act (copy at tab 7 along with a map of locations where these notices were placed at tab 8a). These remained in place for a period of at least 21 days which is the period allowed for objections, the last date being 8 March 2023 (photographs of the notices during this period along with copies of the associated maintenance logs are at tabs 8b - 8k).
- 5. Following the making of the Order, a copy of the CPO and map and the Statement of Reasons were deposited at the venue set out the General Certificate (tab 2a) and were also available of the

Council's website at www.haringey.gov.uk/HRW-CPO and remained available for inspection until 8 March 2023.

6. The Statement of Case was served upon each relevant objector in accordance with Rule 7 of the 2007 Rules and Rule 16 of the 1994 Rules (copies of the email correspondence, letters, confirmation of courier delivery and a certificate regarding hand delivery are at tabs 9a - 9n). A copy of the Statement of Case and the Core Documents accompanying the Statement of Case were also deposited at the same venues of the Statements of Reasons and also made available on the CPO website at https://gateleyhamer-pi.com/en-gb/high-road-west/.

7. In respect of the Pre-Inquiry Meeting:

- 7.1. Copies of the site notice was erected ahead of the Pre-Inquiry Meeting (copy at tab 10).
- 7.2. Photographs of the site notice of the Pre-Inquiry Meeting evidencing the erection and maintenance of the Pre-Inquiry Meeting were taken (copy of a map of locations where these notices were placed at **tab 11a** and photographs at tabs **11b**, **11d and 11e**).
- 7.3. The certificate of billposting dated 29 June 2023 confirmed the site notice of the Pre-Inquiry Meeting was erected (copy at **tab 11c**).
- 7.4. The Inspector confirmed in email correspondence that notice of the Pre-Inquiry Meeting did not need to be published in the local newspaper.
- 8. The Core Documents were submitted to the Inspector electronically via email correspondence on 31 August 2023 (copy at **tab 12a**). The Planning Inspectorate confirmed in email correspondence that hard copies did not need to be submitted and instead hard copies of the Core Documents for use by the Inspector were only required to be brought to the Inquiry.
- Subsequent additions to the Core Documents were submitted to the Inspector electronically via email correspondence on 13 September 2023, 22 September 2023, 10 October 2023, 11 October 2023, 31 October 2023 and 3 November 2023 respectively (copies at tab 12b – 12g).
- 10. In respect of the Statements of Common Ground, a letter was submitted to the Inspector electronically via email correspondence on 15 September 2023 setting out the status of each of the Statement of Common Ground along with a signed and dated Statement of Common Ground with the Tryfonos family (copy at tab 13a)
- 11. Subsequent Statements of Common Ground were submitted to the Inspector electronically via email correspondence on 18 September 2023, 20 September 2023, 6 October 2023 and 10 October 2023 respectively (copies at **tab 13b 12e**).
- 12. The Acquiring Authority's evidence (CD 9.1 9.16, noting there is no CD 9.4 nor CD 9.6) was sent to the Programme Officer and each relevant objector on 10 October 2023 in accordance with Rule 15 of the 2007 Rules (copies of the email correspondence, letters, confirmation of courier delivery and a certificate regarding hand delivery are at **tabs 14a 14I**). The documents have also been

deposited at the venue referred to in the Notice of the public inquiry (tab 16) and are available on

the Council's website https://gateleyhamer-pi.com/en-gb/high-road-west/.

13. Time estimates for presenting evidence and questioning objectors were submitted to the Inspector

electronically via email correspondence on 16 October 2023 (copy at tab 15).

14. Notice of the public inquiry (copy at tab 16) was:

14.1. Attached to the land or to a conspicuous object or place on or near the Order land on

17 October 2023 (copy of a map of locations where these notices were placed at tab 11a and

photographs at **tab 17b**) in accordance with Rule 11(1)(a)9i) of the 2007 Rules. These notices have been maintained on 25 October 2023 and 1 November 2023 (photographs at **tabs 17c**

and 17d).

14.2. The Inspector confirmed in email correspondence that notice of the Inquiry did not need

to be published in the local newspaper.

15. The Core Documents (which includes the Order, Statement of Reasons and Statement of Case)

and copies of evidence sent to or by the Acquiring Authority have been deposited at the venue

referred to in the notice of the public inquiry (tab 16) in accordance with that Notice and Rules 7(6)
