There are a lot of documents in the application, but I can see there are utility diversion plans so this looks to be in order.

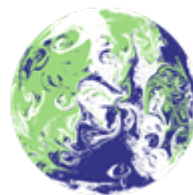

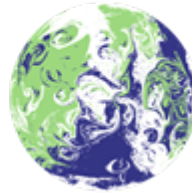
