I will respond briefly to your letter in relation to an insinuation that I can quickly dispel. There is an insinuation that NRF deliberately held back comments on the site sharing plans until 18<sup>th</sup> January in the knowledge that AG had promised to provide the inspector a deed of undertaking on 19<sup>th</sup>. This is incorrect.

In our letter of 11<sup>th</sup> January on the site sharing plans we stated this:

**Please note that our comments on the plans provided in this letter are subject to any our client and/or their technical advisers.**

The reason we stated this is because Mr Richard Abbott remained on his Christmas break until 16<sup>th</sup> January. As you are aware Mr Abbott has been advising BPL on the constructability of the new scheme, and his input has been important in shaping the site sharing plans. We therefore needed to ensure that Mr Abbott had the opportunity to comment on the plans, but we considered it appropriate to send to AG the rest of the team's comments in the interim on 11<sup>th</sup> January as soon as these were ready.

In case of need, I have copied below Mr Abbott's out of office autoreply, you will see that I sent him an email on 10<sup>th</sup> and received this automated response stating that he was away until 16<sup>th</sup>. I'm sure Mr Abbott can confirm his holiday movements if you considered that necessary.
